# BOROUGH OF WHITE OAK Minutes of a Council Meeting January 21, 2019, 8:00 PM

**CALL TO ORDER**: President Dave Pasternak called the meeting to order at 8:00 PM.

Dave Pasternak asked for a Motion to authorize the Borough Manager to purchase a new sound system for Council Chambers at a cost not to exceed \$ 2,700.00 from Northern Sound and Light, Inc.
