Fred Haynes – 98 Carmella Drive – Is opposed to paying \$80,000.00 in salaries, we should be hiring college graduates and getting some new blood in the office. Brian Dinkfelt not doing his job, Mr. Hayes gets no response from Brain Dinkfelt. We should hire 2 corporate secretaries, part-time at 20 hours per week. In February 2013 Mr. Dillinger fired Mr. Petro. We currently have 85 houses for sale on the market. John Palyo assured Mr. Haynes that he would look into his items of concern.
