# BOROUGH OF WHITE OAK Minutes of February 22, 2021 8:00 PM Council Meeting

# This meeting was rescheduled from February 15, 2021 due to inclement weather

Due to the COVID-19 pandemic, our meeting was held at the White Oak Community Center located at 1796 Lower Heckman Road, White Oak, PA. Public access to this meeting was granted following mask and social distancing requirements.

**CALL TO ORDER:** Council Pro Temp Julie Opferman called the meeting to order at 8:00 PM.

<u>MINUTES:</u> George Pambacas made a motion to accept the minutes of the January 18, 2021 Council Meeting. Joseph Nagy seconded the motion. The motion was unanimously approved.

**EXECUTIVE SESSION:** Patricia McGrail announced that prior to the Council meeting on February 22, 2021 Council had an Executive Session to Collective Bargaining matter.

## **PUBLIC COMMENTS:**

Amanda Coats – 422 N. 4<sup>th</sup> Street, Youngwood, PA 15697

I have concerns about White Oak Borough's Feral Cat Ordinance, I do a lot of work with the TNR programs and services and I feel we were duped by the White Oak Council at the February 2020 Meeting.

John Delaney – 531 Sewickley Street, Greensburg, PA 15601

Mr. Delaney asked in reference to the Feral Cat Ordinance, what bought on the changes in the ordinance and if there were complaints (concerning feral cats) are they kept on file?

Ryan Marton – 1805 Kansas Avenue, White Oak, PA 15131

Thanked White Oak Council for adopting a Feral Cat Ordinance.

Mr. Marton wanted to know can the feral cats can be collected and relocated, there has to be other ways to address this problem besides TNR, what other ways are there? Lincoln School Properties Dumpster is a problem area for the feral cats, we also have a coyote problem in White Oak Borough. Mr. Marton was also concerned about the upcoming months of March and April as this usually brings flooding from MAWC lines on Kansas Avenue.

Jen Johnson – 87 Ashley Street, Greensburg, PA 15601

Ms. Johnson stated that she is against White Oak Borough's Feral Cat Ordinance, stated that feeding the feral cats is like feeding Birds or Wildlife. What do expect people to do? Do the TNR program, I do it all over the place.

Carolyn Flam – 112 Ashley Street, Pittsburgh, PA 15221 Attorney of Record

Attorney Flam stated that it is inequity that a White Oak Resident that was cited was feeding the feral cats incorrectly, imagine the dismay to be issued a citation. The White Oak Feral Cat Ordinance had been passed in contrary to what we were told in the February 2020 Council Meeting. This ordinance makes it easier to criminalize the conduct. Notice of passage of the Ordinance was only a legal ad in the Mon Valley Independent on December 11,2020. Attorney Flam says she found the language in the Ordinance too vague and the arbitrary problems of on the record for language, definitions are broad.

Note Attorney Carolyn Flam was given extra time to speak by Donna Priselec – 238 Chicora Street, East McKeesport, PA 15135 Kathy Bridge – 1512 Brinton Road, Pittsburgh, PA 15221 Who forfeited their time to Attorney Flam.

Chris Marton – 1820 Educational Drive, White Oak, PA 15131

Mr. Marton thinks TNR is a good thing, but he sees other side of problem when property is damaged, and the food attracts other wild animals to the area. Mr. Marton would like to see a compromise between both sides.

Dr. Becky Morrow – 730 5th Avenue, New Kensington, PA 15068

Dr. Morrow stated she is an expert in TNR with a Master's Degree, she teaches TNR to her students. Many resources are available to help with the feral cat problem, we can help with targeted TNR, it will get worse if we don't continue the TNR program. Many litters occur per season, one of the resources available are Frankie's Friends Cat Rescue in New Kensington.

Jill Henkel – Turtle Creek Councilwoman (Council President Pro Temp), Turtle Creek, PA 15145 Councilwoman Henkel stated she would like the White Oak Borough Feral Cat Ordinance rescinded, she is a TNR program operator and in September 2020 at a TNR event in Turtle Creek they had 60 feral cats neutered, Turtle Creek donated \$500.00 towards the cost of addressing the problem, education is the key thru TNR workshops.

Jodi Perozich - 2800 Lincoln Way, White Oak, PA 15131

Ms. Perozich stated that she has researched the feral cat ordinance and the procedures for TNR is to only feed two (2) times per day, and she is aware of property damage occurring to neighbor's property and to her garden as well. Complaints should be made not to the neighbors but to the owner. Neighbor disputes if you can't settle take Civil Action. This issue has nothing to do with the White Oak Animal Shelter, attacking the shelter's is counterproductive. Cat Feeders expert others to deal with their problem, it is complicated, fund shelters and not tear down the shelter organization.

George Pambacas – 1709 Educational Drive, White Oak, PA 15131

Mr. Pambacas stated that his home sets 1200 ft from Horizon Drive, he has had a parade of cats leaving stuff, your responsible for the feral cat's actions. An audio was played of cats meowing loudly outside of Mr. Pambacas' home. Out of Towners come in to tell us how to run our business, we need to have civil discussions to correct the problems.

An attendee stated, "No rescuers will come into White Oak Borough to help correct the problem, with the current White Oak Feral Ordinance in place."

Julie Opferman closed the public session of the meeting.

Mayor Ina Marton asked to say a few words: Mayor Marton expressed her love of animals and the development of the shelter. She discussed that the shelter does offer TNR assistance with spay, neuter and veterinary care and has provided that care within the community. Announced that since its inception in 2003, WOASH has adopted over 16,000 pets to their "furever" homes. She stated while she serves as Mayor of the Borough and President/ Founder of the WOASH they are two completely separate entities. Council approved the Ordinance and that she attested to its approval and not necessarily agreed with the ordinance language. She thanked those in attendance for not attacking her and supporting her at the White Oak Animal Safe Haven Shelter. She stated that she would reach out to Dr. Morrow for some assistance and they exchanged contact information.
