George Dillinger seconded the motion. The motion was unanimqusly approved.

George Dillinger made a motion to approve Pay Request #6 in an amount of \$17,581.19 submitted by BZ Construction, under Contract #1 - General as part of the Borough Facilities, General, Roof, HVAC & Electrical Replacement Project as reviewed and approved by the Engineer and authorize the Borough Manager to sign the above listed request on behalf of the Borough. Julie Opferman seconded the motion. The motion was unanimously approved

Julie Opferman made a motion to approve Pay Request #5 in an amount of \$45,771.30 submitted by Reno Brothers, Inc. under Contract #3 – HVAC and Plumbing as part of the Borough Facilities, General, Roof, HVAC & Electrical Replacement Project as reviewed and approved by the Engineer and authorize the Borough Manager to sign the above listed request on behalf of the Borough. George Dillinger seconded the motion. The motion was unanimously approved.

Julie Opferman made a motion to award the Bid for the 2022 Borough Storm Sewer & Inlet Replacement Project to Pugliano Construction in the amount of \$849,000.00 and authorize the President and Borough Manager to execute all documents pertaining to the project as recommended by our Engineer. George Pambacas seconded the motion. The motion was approved, however, Council Member George Dillinger obtained as this would be a 2022 expense and won't be on Council.

Julie Opferman made a Motion to authorize the Engineer to proceed with the preparation and filing of an application under the US Army Corps of Engineers for funding assistance to address streambank erosion issues along Long Run in White Oak and authorize the Borough Manager to sign on behalf of the Borough. George Pambacas seconded the motion. The motion was unanimously approved.

Ken Hillman gave a progress report to council on the various projects that are still in process in the borough and estimated completion dates.

SOLICITOR'S REPORT: Ms. Patricia L. McGrail

George Dillinger made a motion to accept the Solicitor's Report and pay the fees due to McGrail & Associates, LLC for Invoices 36888, 37597, 598, 599, 601, 602, 605, 609 and 621, dated December 9, 2021 totaling \$4,670.00. Julie Opferman seconded the motion. The motion was unanimously approved.

Solicitor McGrail informed council that as of today her firm had collected \$171,000.00 in Delinquent. We currently they have 6 complaints at the District Justice's office for judgements on unpaid Solid Waste fees.
