# **ORDINANCE NO. 2023-16**

AN ORDINANCE OF THE COUNCIL OF THE BOROUGH OF WHITE OAK, ALLEGHENY COUNTY, COMMONWEALTH OF PENNSYLVANIA, AMENDING ORDINANCE NO. 2017-24 TO AUTHORIZE THE INSTALLATION OF AN OFFICIAL STOP SIGN AT THE INTERSECTION OF REIMAN STREET AND CLARK STREET WITHIN THE BOROUGH OF WHITE OAK

**WHEREAS**, Chapter 61 of the Pennsylvania Vehicle Code, 75 PA C.S. §§ 6101 et seq., grants authority to local municipalities to ordain reasonable rules and regulations for the control of the movements of motor vehicle traffic; and

WHEREAS, the Pennsylvania Vehicle Code, particularly Sections 75 PA C.S. §§ 6109 and 6124, gives local municipalities the authority to erect and maintain stop signs and designate an intersection and junction of roadways as stop or yield intersections or junctions; and

WHEREAS, after conducting an traffic investigation, Gibson-Thomas Engineering recommended that a stop sign be placed on Reiman Street approach to Clark Street within the Borough of White Oak;

**WHEREAS,** the Council of the Borough of White Oak previously adopted Ordinance No. 2017-24 which established stop signs and stop intersections within the Borough; and

WHEREAS, the Council of the Borough of White Oak has determined that amending Ordinance No. 2017-24 is necessary to promote to convenient and safe movement of motor vehicles within and through the Borough of White Oak and to adequately protect both the safety and welfare of Borough residents as well as those traveling within the Borough of White; and

NOW THEREFORE, BE IT ORDAINED AND ENACTED and IT IS HEREBY ORDAINED AND ENACTED by the Council for the Borough of White Oak, Allegheny County, Pennsylvania, as follows:

## **SECTION 1**

Ordinance 2017-14 is hereby amended to add a stop sign at the following location:

Stop Street Intersecting or Through Street Direction of Travel

Reiman Street Clark Street East

# **SECTION 2**

The Borough Manager or designee is hereby directed to erect an official stop sign pursuant to this Ordinance.

#### **SECTION 3 - REPEALER**

All the remaining provisions of Ordinance 2017-14 shall remain in full force and effect. However, as of the effective date of this Ordinance, all ordinances currently in existence are repealed to the extent that such ordinances are inconsistent with the provisions of this Ordinance.

### **SECTION 4 - SEVERABILITY**

The provisions of this Ordinance are severable. If any section, sentence, or clause of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining sections, sentences or clauses of this Ordinance.

# **SECTION 5 - EFFECTIVE DATE**

This Ordinance shall become effective upon enactment by the Council of the Borough of White Oak.
