RESOLUTION NO.

NOW, THEREFORE, Council, in meeting assembled, resolves as follows:

1. Council does hereby approve and adopt the additions or amendments to the Schedule of Fees attached hereto as Exhibit "A: and incorporated herein by reference thereto.
2. Any fees established by prior resolution or ordinances, which are inconsistent with the attached schedule of fees, are hereby revised and modified accordingly.
3. The additions or amendments to the schedule of fees established by this Resolution shall become effective immediately.
