MINUTES OF THE REGULAR MEETING OF WHITE OAK BOROUGH COUNCIL HELD MONDAY, JANUARY 21, 2013 AT 7:30 P.M.

CALL TO ORDER

Mr. Pasternak, President of Council, called the Regular Meeting to order at 7:30 p.m.

PLEDGE OF ALLEGIANCE

The Pledge of Allegiance was given.

ROLL CALL

Attending were Council members: Edward Babyak, Charles Davis, George Dillinger, Ronald Massung, David Pasternak, Carrie Noll and Kenneth Robb. Also attending were Mayor Ina Marton, Solicitor Patricia McGrail, Engineer Representative Donald Hultberg, Borough Manager John W. Petro, Jr. and Borough Secretary Nancy Greenland.

Mr. Pasternak asked for a moment of silence to pay respects to Terry Leckman, Borough Solicitor, who passed away at the end of the year.

Mr. Pasternak asked for a motion to change the order of business for several issues.

A motion as made by Mr. Dillinger, seconded by Mr. Babyak, to change the order of business.

Motion carried unanimously.

A motion was mad by Mr. Babyak, seconded by Mr. Massung, to appoint Patricia L. McGrail, as Interim Solicitor, for the Borough of White Oak and authorizing the proper officials to sign said Engagement Letter.

Motion carried unanimously.

A motion was made by Mr. Babyak, seconded by Mr. Dillinger, to accept the resignation of Louis G. Bender from the position of Lieutenant within the police department.

Motion carried unanimously.

A motion was made by Mr. Babyak, seconded by Mr. Davis, to appoint Louis G. Bender, as Chief of Police, to the White Oak Borough police department, effective immediately.

Motion carried unanimously.

Page 1 of 12 Regular Meeting January 21, 2013 A motion was made by Mr. Babyak, seconded by Mr. Massung, authorizing the proper officials to enter into and sign a Salary/Benefit Agreement with Louis G. Bender, with regards to the position of Chief of Police.

Motion carried unanimously.

Mayor Marton administered the Oath of Office to Louis Bender.

Ms. Marton noted last month Chief Hoffman retired. She stated Chief Bender is now filling the shoes of Chief Hoffman, which we didn't thing we could do. She commented she felt Chief Bender would do a fine job. He will be given all the support he needs for this endeavor.

Chief Bender thanked Council for giving him the opportunity to serve the Borough as Chief. He noted it was a tough decision between two very good candidates. He again thanked Council for the honor and privilege of being able to serve as the chief of police. He also thanked his family and friends for all the support they have given him over the years. He thanked Chief Hoffman who helped train him for the position and also training him in martial arts. He expressed his appreciation for the support that is giving by the fire departments and EMS and his fellow officers. He stated he know the sacrifices the individuals make on a daily basis. He noted he was aware of all the dedication and pride the officers have for the department and that he was very honored to be able to lead the officers over the next few years. He stated he wants the department to continue to provide the high standards that have already been set and to be aggressive on crime and protect residents, businesses, visitors and especially the children. He noted the department will continue to be proactive.

PUBLIC COMMENTS

Glenda Roberts – Lot 67, 3301 Jacks Run Road "Biros Trailer Court"

Ms. Roberts presented Council with a petition regarding the collection of garbage, within the trailer court, not being provided since the end of December. She indicated she was advised by Mr. Petro that the landlord was to provide this service and asked if he had been cited as yet.

Ms. McGrail indicated Mr. Biros had filed a complaint with the Court of Common Pleas for an Injunctive Relief. The court did not grant the relief, but we have been advised of the owners' intention to amend the complaint. She noted the Borough does have a legal ordinance. Notice was given to the owner that service would no longer be provided as of the end of 2012 and that the owner would be responsible for providing said service.

Peggy Pokrant – Lot 51, 3301 Jacks Run Road "Biros Trailer Court"

Ms. Pokrant indicated the residents of the trailer court were being discriminated again, noting they pay real estate taxes and are now being excluded from the collection.

Mr. Petro noted any residential site that has more than 2 units is considered a commercial operation. This doesn't just affect the trailer court. The ordinance was adopted in mid 2011, but no action was taken on the change until 2013. Appropriate property owners were notified in 2012 about the change.

- Mr. Pasternak stated this site is technically considered a commercial operation.
- Ms. Pokrant then asked why the recycling truck had gone through the court last week.

Mr. Petro indicated he would contact the contractor to make sure it was aware it should not be Picking up recycling in the court.

Frank Lovin – Lot 19, 3301 Jacks Run Road "Biros Trailer Court"

Mr. Lovin commented that the residents in the trailer court are being treated like they don't belong to White Oak.

Ms. McGrail advised that residents of the trailer court still belong to White Oak. They would just be paying a fee to an outside hauler for garbage collection.

Carolyn Leitzel – 2155 Lewis Street

Page 3 of 12 Regular Meeting January 21, 2013 Ms. Leitzel noted that since Mr. Ferree was hired as dog catcher it has been noted he brings dogs to the White Oak Animal Safe Haven for placement. She further noted that euthanasia is defined as a good death and wanted to know what Ms. Marton was doing to make sure Ferree was complying with legislation passed in 2012 that bands the use of carbon monoxide.

Ms. Marton noted the Mr. Ferree has a contact with the Borough not the shelter. He has been working with the shelter on placing adoptable dogs. Since the contract took effect he has turned 48 dogs over for adoption. She advised that it would be the responsibility of the state to monitor the methods of euthanizing animals as Mr. Ferree is licensed by the state.

Ms. Leitzel stated that if Ms. Marton cared about animals she would do something.

Stan Napierkowski – Lot 28A, 3301 Jacks Run Road, "Biros Trailer Court"

Mr. Napierkowski indicated he understood payment for garbage collection would be made to Mr. Biros. He asked if that payment would be more than what the Borough pays.

Mr. Pasternak stated the property owner would negotiate with a hauler to determine what the rate would be.

Ms. McGrail commented that this was a conversation the residents of the trailer court should have with Mr. Biros. The Borough cannot get involved with the property owner.

Glenda Roberts - Lot 67, 3301 Jacks Run Road "Biros Trailer Court"

Ms. Roberts asked if the Borough would get after the property owner if he doesn't follow through and can the Board of Health be contacted.

Mr. Petro advised contact has already been made with the Allegheny County Health Department.

Reida Linguist – Lot 107, 3301 Jacks Run Road "Biros Trailer Court"

Ms. Linguist asked who excluded the trailer court from the contract.

Mr. Pasternak noted the ordinance was adopted by Council.

Bob Johnston – Lot 6, 3301 Jacks Run Road "Biros Trailer Court"

Mr. Johnson noted in the past he paid for services at a site on Lincoln Way.

Mr. Pasternak stated that would have been the Borough's billing company, Keystone Collections Group.

Mr. Pasternak called for a 10 minute Executive Session.

Council reconvened the Public Meeting at 8:02 p.m.

Ms. McGrail advised Council discussed the issue of garbage collection at the Biros Trailer Court. She noted that the Code Enforcement Officer will be instructed to cite Mr. Biros for non-compliance and that every day that the garbage is not picked up will be considered a violation.

She noted officials have been in-touch with Mr. Biros' attorney to try to resolve the matter.
