# **HEALTH, ENVIRONMENT AND CABLE**

Ms. Verbanick, Chairperson, Chairperson, noted there would be a one day delay in the garbage collection due to the Thanksgiving Holiday. #### PARKS AND RECREATION

Mr. Robb, Chairperson, announced the Recreation Board would be sponsoring a Holiday Craft Show. This will be held on Saturday, December 4<sup>th</sup> from 10:00 a.m. until 4:00 p.m. at the White Oak Athletic Association.

Mr. Robb noted the Recreation Board is sponsoring an Evening with Santa, which will be held on Sunday, December 5<sup>th</sup> starting at 6:00 p.m. at the White Oak Athletic Association.

Mr. Robb stated the Borough was approached by Rainbow Volunteer Fire Company to see if the Borough would assist it in holding the "Season of Lights" event. The event is set for Saturday, November 20<sup>th</sup>. It includes pancake lunch/dinner at Rainbow Fire Hall from 2 to 5, Santa will also be attending. Santa will then arrive by fire truck at Oak Park Mall at 6:00 p.m. at which time the Christmas tree will be lit and Santa will meet with the children and provide treat bags. Cookies along with coffee and hot cocoa will be serviced and you will be able to listen to various choirs singing carols.

#### PLANNING, ZONING AND CODE ENFORCEMENT

Mr. Babyak, Chairperson, noted there were 21 permits issues for a total of \$877.00 in fees for the month of October there were also 11 violation notices issued.

A motion was made by Mr. Babyak, seconded by Mr. Dillinger to accept the preliminary and final approval of the Rite Aid site plan.

#### **PUBLIC SAFETY**

Mr. Massung, Chairperson, announced the Borough would be accepting applications for parttime police/patrol officers at any time. Candidates must have Act 120 Certification and can pick up the necessary application packets at the Borough office. A motion was made by Mr. Massung, seconded by Mr. Dillinger to install a street light at the corner of Carmella Drive and Longvue Drive. He noted the Borough received a petition requesting the lighting and this has been reviewed and recommended by the police department.

Motion carried unanimously.

#### **PUBLIC WORKS**

Mr. Davis, Chairperson, indicated he had several motions to introduce and several announcements.

Mr. Davis announced the Leaf Composting Program will end Friday, December 3<sup>rd</sup>. There will be no pick up on November 11, 25 or 26. These are scheduled holidays for the Public Works department.

A motion was made by Mr. Davis, seconded by Mr. Dillinger, authorizing payment in the amount of \$753,007.91 to Morgan Excavating L.P. for work performed in the month of October.

Motion carried unanimously.

A motion was made by Mr. Davis, seconded by Mr. Babyak, authorizing the proper officials to sign Change Order 2 in the amount of \$19,281.00 for additional work on Public Road, inlet riser and High Drive and Public Road, milling; Change Order 3 in the amount of \$2,895.00 for additional work on Rankin Road, inlet riser and Center St. raise manhole; Change Order 4 in the amount of \$25,000 for additional work on Clark Street – subgrade; Change Order 5 in the amount of \$5,200.00 for additional work on Congress Street – 12" DR14 Pipe installed; with Morgan Excavating L.P. under Contract 9775-10-01.

Mr. Massung asked if this was the final payment on the project.

Mr. Hultberg noted this would be the next to the last payment for construction (excludes payment of the retainage amount)

Motion carried unanimously.

A motion was made by Mr. Davis, seconded by Mr. Robb, authorizing the proper officials to sign the Certificate of Substantial Completion with Morgan Excavating L.P. on contract 9775-10-01. This has been approved by the Borough's Engineer, The EADS Group.

Motion carried unanimously.

Mr. Davis announced that Duquesne Light would be installing/upgrading equipment along Cool Springs Road and Poinsettia Drive within the next several weeks.
