Health, Environment and Cable

Mr. Davis, Chairperson, indicated he had several motions to present.

A motion was made by Mr. Davis, seconded by Mr. Robb, authorizing the proper officials to file a municipal lien against TRW Holdings, Inc., for unpaid garbage/sewer at 1002 Bennett Street-Block & Lot 461-E-91.

Parks and Recreation & COG Representative

Mr. Pasternak, Chairperson, stated the Recreation Board held The Holiday Craft show on Saturday, December 1st and Evening with Santa on Sunday, December 2nd. Both events were held at the WOAA.. He advised the Borough donated the funds originally set aside for Light-up Night to the Board for use for the Evening with Santa. The Board purchases \$5.00 gift certificates from Toy-R-Us and distributed those to the children.

The Recreation Board in conjunction with the White Oak Athletic Association will sponsor a New Year's Eve Party set for December 31 from 9:00 p.m. until 1:30 a.m. - \$25.00 per adult (21 or older) at WOAA – proceeds to benefit WOAA and Recreation Board. Food being served is kielbasa, saukeraut, mashed potatoes, pork roast, chicken breast, beer and soda. Anyone wishing anything else to drink may BYOB.

Mr. Pasternak noted the City of Duquesne would be joining Twin Rivers COG and that West Mifflin would be leaving in 2008. West Mifflin will become a member of Steel Valley COG. Twin Rivers COG sent a letter to West Mifflin asking for an exit interview.

Planning, Zoning and Code Enforcement Officer's Reports

Mr. Babyak, Chairperson, noted there were 12 violation notices sent out in November. Twenty-seven (27) permits were issued with fees totaling \$2,128.20.

A motion was made by Mr. Babyak, seconded by Mr. Davis to accept the resignation of Stephen Tomko from the Planning Commission.

A motion was made by Mr. Babyak, seconded by Mr. Dillinger, to appoint Anthony Villinger to fill the unexpired term of Mr. Tomko on the Planning Commission. The term expires the first Monday in January of 2011.

A motion was made by Mr. Babyak, seconded by Mr. Davis, to accept the resignation of Anthony Villinger from the Zoning Hearing Board.

Motion carried unanimously.

A motion was made by Mr. Babyak, seconded by Mr. Massung, to appoint David Preece, the current alternate to the Zoning Hearing Board, to fill the unexpired term of Mr. Villinger. The term expires the first Monday in January of 2010.

Public Safety

Mr. Massung, Chairperson, reported that Chief Hoffman and District Justice Miller made arrangements for a tour of the County Jail and Night Court. The tour was conducted on December 10 and approximately 42 residents attended. He noted there were a lot of young people being processed or held. He stated he felt that all young people should tour the facility and visit the court system to see what it is like. He stated it was a real eye opener on how one small mistake can change your life.

Mr. Massung thanked the Chief and District Justice for setting up the tour.

Mr. Massung suggested that anyone interested in hearing the Mon Yough Community Singers could attend a concert on Monday, December 24 at St. Angela Church. The group will be giving a concert at 3:45 p.m. as well as singing at midnight mass at 11:00 p.m.

Mr. Massung stated residents in the area of Tangleview, Stewartville Hollow Road were receiving notices from Huntley and Huntley regarding the possibility of drilling gas wells. He advised that Huntley and Huntley is regulated through DEP and that there is not much the Borough can do with this matter.
