Mr. Haynes noted Ms. O'Brien replaced Wayne Washowich, who was released for not securing state certification, doesn't have her state certifications. He indicated she is not permitted to sign off on even a roofing permit and that she should not be able to use the Borough vehicle.

He requested council consider pulling the hard drives of the office staff and having those decoded to see who much personnel business is being conducted by staff.

He also indicated there were several mistakes in the budget but was unable to get an answer to several questions he had this afternoon, as Ms. Greenland was preparing for tonight's meeting.

Ms. Noll responded to one of the comments made by Mr. Haynes that Mr. Washowich retired and based on the current duties Mr. O'Brien is performing she is not required to have state certification. Ms. O'Brien just recently secured the necessary credits she needs in order to take the certification course/test.

Mr. Haynes insisted that she is required to have at least two (2) certifications. This is what he is being told by the instructor, who he personally knows.
