CALL TO ORDER

Mr. Petro, President of Council, called the Regular Meeting to order at 8:00 p.m.

PLEDGE OF ALLEGIANCE

Mr. Petro led those attending in the Pledge of Allegiance.

MINUTES

Mr. Petro asked if there were any additions or corrections to the following Minutes:

EXECUTIVE SESSION

Mr. Leckman stated there were various sessions held and during such sessions pending litigation and personnel matters were discussed.

PUBLIC COMMENTS

Mr. Petro advised those in attendance that Council is unable to respond to any questions regarding legal or personnel matters at the public meeting and that anyone wishing to speak would be limited to three (3) minutes.

No one in attendance had any comments.

REPORTS OF CHAIRPERSONS OF STANDING COMMITTEES

President's Report

Mr. Petro noted a meeting was held with representatives of the U.S. Postal Service including William Mueller, Postmaster of our local Post office Branch, Elizabeth Gordon, Acting Manager of Consumer Affairs and other. The meeting was arranged by Congressman Murphy with support from Senator Logan Senator Arlen Specter and County Councilman Bob Macey. The meeting was well attended by Borough Council and the Mayor. The group was presented wit a mountain of information showing the confusion caused by the address change of White Oak, PA 15131 to McKeesport, PA 15131, as well as petitions signed by over 7,000 White Oak residents and businesses requesting the Postal Service retain White Oak, PA 15131 as our proper mailing address.

IT was interesting to find that U. S. Postal Managers were unaware of any changes that were taking place with respect to White Oak 15131 being defaulted to McKeesport 15131. Postal representatives had done some preliminary research and stated they have no issues with the address line reading White Oak, PA 15131. It was felt there was an unknown glitch in their system and their respective staff personnel were at work to uncover the glitch and rectify it.

Ms. Gordon informed those in attendance that local postal staff was manually going through the White Oak Borough data base to insure that White Oak PA 15131 is an acceptable bottom line to the address of all White Oak businesses and residents. Further, the U. S. Postal Service at a regional level was combing their system to ascertain how this glitch was created and by whom. Ms. Gordon committed to inform Congressman Murphy and the Borough as soon as they have a result form their investigation.

At the close of the meeting, Postmaster Mueller stated that White Oak residents and businesses should continue to use White Oak, PA 15131 as their address. Mr. Mueller also stated that credit card companies, airlines and others may take as long as the end of March to make zip code corrections to their databases on a quarterly basis and the McKeesport 15131 default would be rectified shortly after March.

White Oak Council and Mayor certainly appreciated the quick action of the Post Service prompted by the support of Federal, State and County officials for their assistance in resolving this troublesome matter.
