MINUTES OF THE REGULAR MEETING OF WHITE OAK BOROUGH COUNCIL HELD MONDAY, FEBRUARY 21, 2011 AT 8:00 P.M.

CALL TO ORDER

Mr. Pasternak, President of Council, called the Regular Meeting to order at 8:00 p.m.

PLEDGE OF ALLEGIANCE

The Pledge of Allegiance was given lead by scouts Alec Regan and Bradley Kitchen.

ROLL CALL

Attending were Council members: Edward Babyak, Charles Davis, George Dillinger, Ronald Massung, David Pasternak, Kenneth Robb and Carrie Verbanick. PRESENTATION OF CERTIFICATES OF ACHIEVEMENT

Ms. Verbanick noted that in September the Borough was contacted by Boy Scouts Alec Regan and Bradley Kitchen asking why the Borough did not recycle plastics. A meeting was held with the young gentlemen and they were advised that the Borough was not required to recycle plastics, the cost to collect and the limited market for the product was cost prohibitive. Prior to meeting with the scouts they had gathered information and located a company called Greenstar that recycles plastics in the Pittsburgh area. Contact was made with Greenstar who informed the Borough they recycled plastic for Elizabeth Twp. whose recycling is picked up through Twin Rivers COG, who also picks up the borough recycling. Contact was then made with John Palyo of Twin Rivers COG who indicated the plastics could be added to our program without any additional cost to the Borough.

Alec and Bradley got together and decided to conduct a poster contest in the local schools to promote the expanded recycling program. A number of students participated in the contest and the poster chosen to promote the plastic recycling was designed by Nicholas nightingale a 5th grader from Francis McClure Middle School. The poster will be displayed at the schools and the through out the Borough to promote recycling. It will also be featured in this year's municipal map and newsletters.

Ms. Verbanick thanked Scouts Regan and Kitchen for their efforts in expanding the borough's recycling program and presented each with a Certificate of Appreciation from the Council and the Mayor.

Scoutmaster George Shaffer presented the scouts with a badge recognizing their efforts in advancing recycling in the Borough.
