MINUTES OF THE REGULAR MEETING OF WHITE OAK BOROUGH COUNCIL HELD MONDAY, MAY 17, 2010 AT 8:00 P.M.

CALL TO ORDER

Mr. Pasternak, President of Council, called the Regular Meeting to order at 8:00 p.m.

Mr. Pasternak noted there were two scouts in the audience who are going to be working on their Eagle Scout Badge. He asked that they lead the group in the Pledge of Allegiance

PLEDGE OF ALLEGIANCE

The scouts led those attending in the Pledge of Allegiance.

ROLL CALL

Attending were Council members: Charles Davis, George Dillinger, Ronald Massung, David Pasternak, Kenneth Robb and Carrie Verbanick. Also attending were Mayor Ina Jean Marton, Solicitor Terry Leckman, Engineer Representative Donald Hultberg, Borough Manager John W. Petro, Jr. and Borough Secretary Nancy Greenland.

Council member Edward Babyak was absent.

MINUTES

Mr. Pasternak asked if there were any additions or corrections to the following Minutes:

There were none.

A motion was made by Mr. Massung, seconded by Mr. Davis, to accept the Minutes as presented.

Motion carried unanimously.

EXECUTIVE SESSION

Mr. Leckman stated there were various sessions held and during such sessions pending litigation and personnel matters were discussed.

PUBLIC COMMENTS

Jeff Winowich – 2110 Fawcett Avenue

Page 1 of 10 Regular Meeting may 2010.doc Mr. Winowich expressed concern about the pooling of water in front of his home. He noted the fall for rain water on the street is very limited and he had presented the matter in the past with the officials. He asked if there was any thing that was scheduled to be done to correct the problem, noting it is more of a nuisance than anything.

Mr. Petro noted the matter has been reviewed by the Public Works department and the issue is the lack of a catch basin in the area as well as the layer upon layer of asphalt. He advised the Borough has a multi-year major road rehab project coming up and work is scheduled for Fawcett Avenue but he wasn't sure if it took in this area.

Mr. Winowich also suggested a stop sign be installed between Henderson and Oliver Drive on Fawcett Avenue. He suggested the sign be erected at Spruce Way.

Mr. Petro suggested a petition be circulated amongst the neighbors. Once it is received it will be turned over to the Police Department for review and a recommendation.

Katherine Malloy – 213 Sunset Drive

Ms. Malloy expressed concern about 215 Sunset Drive, which has been empty since the fall. She noted the brother of the owner indicated the owner was in a care home. The grass is excessive in height and asked if the Borough could get the grass cut under section 733.03 of the Borough's codified ordinances.

Mr. Petro noted there was a discussion on this site last week and further advised that proper notice has to be issued to the owner giving time to correct the problem. He indicted he would discuss the complaint with Mr. Washowich, Code Officer, in the morning.

Mr. James McCabe, Public Works Supervisor, stated the owner passed away last weekend.

Mr. Pasternak indicated the Borough would contact the appropriate party giving them time to correct the issue and if not completed by the deadline the Borough would then contact its landscape contractor to rectify the problem.

Rebecca and Frances Weiss - 1037 Amherst Street

Ms. Weiss indicated that for three (3) years she and her sister have been tormented and harassed by their neighbor at 1035 Amherst Street. The neighbor just moved out leaving garbage/debris on the site as well as an abandoned vehicle. She further advised the grass is very high and in need of being cut. Cans of hazardous chemicals were left on the porch and a small pool with water in it is in the backyard.

Mr. Petro noted he would address this matter with Mr. Washowich, the Code Enforcement Officer.

John Tokarska – 537 McCully Street

Mr. Tokarska presented a petition signed by residents of McCully Street reporting speeding along McCully as well as the lack of proper signage along the roadway. She noted the wasn't a stop sign (going up hill) until you get to Prescott Street, there is only one Watch Children sign. He

suggested Monongahela and McCully be a three way stop, that speed limit signage be installed along with additional Watch Children signs and Hidden Driveway signs.

Chief Hoffman noted the he has spoken with Mr. Tokarska and advised the Borough would be installing a speed strip along McCully Street. The data from the strip will assist in determining what can be done to rectify the complaint about speeding.

REPORTS OF CHAIRPERSONS OF STANDING COMMITTEES

President's Report

Mr. Pasternak asked for a motion authorizing the issuance of a letter opposing House Bill 243. He noted the proposed legislation would only permit local governments to exist under the jurisdiction of the county. The county would determine what type of duties the municipal officials would perform as well as being tasked with control of personnel, law enforcement, land use/zoning regulations, sanitation and health and safety issues. If adopted there would virtually be no local government.

A motion was made by Mr. Robb, seconded by Mr. Davis, to author a letter opposing adoption of HB 2431.

Motion carried unanimously.

Mrs. Marton asked Chief Hoffman to come forward and speak regarding the paper link chain on display across the dais.

Chief Hoffman noted this was prayer/thank you chain made by the 214 students and staff at St. Angela Merici Catholic School. This coincided with May 9-16 being National Police Week. The students asked about making a donation to an organization in the name of our department. It was suggested a donation be made by St. Jude Children's Research Hospital. The organization conducts research and treats children with life threatening diseases.

He noted that 2009 was a difficult year in Western Pennsylvania for police officers. Four officers were fatally shot (3 from Pittsburgh, 1 from Penn Hills). There ware currently 900,000 sworn officers in the United States. One officer is killed about every 53 minutes, 56,000 are assaulted annually with 16,000 receiving significant injuries.

The Chief thanked the students and staff for their thoughts.
