HEALTH, ENVIRONMENT AND CABLE

Mr. Davis indicated he had several items to announce and a motion to present.

A motion was made by Mr. Davis, seconded by Mr. Dillinger, to satisfy liens GD96-10741 and GD98-9638 filed against Florence Shoben and Marilyn Shoben – 1601 Summitt Street – Block & Lot 461-S-66 for delinquent garbage fees. The Liens have been paid in full.

Motion carried unanimously.

Mr. Davis announced there would be no delay in the garbage collection on Friday. Good Friday is not a scheduled holiday for the hauling company.

Mr. Davis announced the Rabies Clinic is set for Saturday, May 3, 2008 from 12:00 noon until 2:00 p.m. Charge: White Oak Residents Free -- Non Residents \$10.00. Additional pet inoculations for both residents and non-residents are available for a fee of \$15.00 for each of the following inoculation for dogs DHLPP or Bordetella and for cats the FVRCP or FELV. Proceeds benefit the White Oak Animal Safe Haven.

PARKS AND RECREATION AND COG REPRESENTATIVE

Mr. Pasternak, Chairperson, announced the Recreation Board would be sponsoring an Easter Egg Hunt on Saturday, March 22 at 10:00 a.m. at the pavilion at Heritage Hill Park.

Mr. Pasternak noted the Borough is accepting applications for the position of life guard.

Mr. Pasternak advised the Annual Twin Rivers COG Dinner Meeting is scheduled for Thursday, March 27th. He further noted the Borough would be receiving \$700.00 in funding through a Council of the Arts Grant. The funds will be used to assist in covering a small portion of the expenses associated with Community Day.

Mr. Pasternak indicated Twin Rivers COG was awarded a grant in the amount of \$25,000.00. The funds will be used to assist in the purchase of a new used street sweeper. COG currently has a contract with Penn DOT to sweep Penn DOT right of ways and those funds will be used toward payment of the loan.

Mr. Pasternak recognized Bill Alund for the design of a logo for the Borough's 60th Anniversary.

PLANNING, ZONING AND CODE ENFORCEMENT

Mr. Babyak, Chairperson, stated during the month of February 13 permits were issued for fees totaling \$1,489.90. There were also 13 violation notices issued during the month.

A motion was made by Mr. Babyak, seconded by Mr. Davis, authorizing the proper officials to file liens for the costs associated with demolition against 186 Heckman Road 549-S-060 \$7,500 plus legal/advertising costs in the amount of \$411.25, totaling \$7,911.25 and 1045 Lincoln Way 461-C-36 \$22,000 plus legal/advertising/fencing in the amount of \$2,889.25 totaling \$24,889.25.

Mr. Babyak noted a public information meeting would be held on April 9 at 7:00 p.m. in the Municipal Building with regards to a possible zoning change along Jacks Run Road from residential to commercial. Residents in the proposed area of change have been notified of the meeting.

PUBLIC SAFETY

Mr. Massung, Chairperson, indicated the Red Cross Evacuation Team is in the process of trying to secure agreements to use the following sites in the Borough as shelter sites: White Oak Athletic Association, Rainbow V.F.C., American Legion, White Oak #1, St. Angela Church, Penn State, McKeesport Area School District, as well as, several other site locations.

PUBLIC WORKS

Mr. Robb, Chairperson, noted the monthly activity report for the Public Works Department was available for review during normal business hours.

He further advised that Five R Excavating, Inc. has notified the Borough that it anticipates Penn DOT's McClintock Road Bridge Replacement Project to begin March 31. The Borough has not been informed how long the project will taken and how long the detour will be in place.
