# MINUTES OF THE REGULAR MEETING OF WHITE OAK BOROUGH COUNCIL HELD MONDAY, JULY 18, 2016 AT 8:00 P.M.

### **CALL TO ORDER**

Mr. Massung, President of Council, called the Regular Meeting to order at 8:00 p.m.

### PLEDGE OF ALLEGIANCE

The Pledge of Allegiance was given.

### **ROLL CALL**

Attending were Council members: Edward Babyak, Richard Bryce, Charles Davis, Ronald Massung, Joseph Nagy, and David Pasternak. Also attending were Mayor Ina Marton, Solicitor Krisha DiMascio, Daniel Coffman, Engineer Representative and Borough Secretary Nancy Greenland.

Council member Kenneth Robb was absent.

#### **MINUTES**

There were no Minutes submitted for approval at this time.

#### **EXECUTIVE SESSION**

Mrs. DiMascio stated an Executive Session was held at the Workshop earlier this month a short session would be held after the meeting.

### **PUBLIC COMMENTS**

Stan Chronowski – 1900 Lincoln Way, White Oak, PA 15131

Mr. Chronowski asked who was responsible for maintaining the grassy area on both side of Henderson Road at Lincoln Way as well as the grassy strip that runs between the curb and sidewalk and the sidewalks along Lincoln Way.

Ms. DiMascio stated that grassy area on both side of Henderson Road is still owned by Penn DOT. The Borough has agreed to maintain that area once Penn DOT turns the area over to the Borough. As for the sidewalks and grassy area between the curb and sidewalk, the property owner would be responsible to cut the vegetation as well as maintain the sidewalks.

Mr. Chronowski asked if the grassy area could be developed.

Ms. DiMascio noted the Borough would determine how that area would be used. A small park, fountain or signage could be placed there.

### Rick Russo – 1611 Vermont Avenue

Mr. Russo stated there was a tremendous amount of water entering in yard from a clogged storm sewer several doors away from him.

### <u>Larry Analauf - White Oak Rotary</u>

Mr. Analauf indicated the Rotary has raised approx. \$14,000.00 to construct a band shell at Heritage Hill Park. It is proposed the shell be set about 4 feet off the ground and have a 32 foot wide stage area.

### Maruti – 1100 Fawcett Avenue (gasoline sales)

Mr. Maruti stated he had a zoning issue at his place of business. It seems the use of the facility, which was grandfathered, changed about 4 or 5 years ago and he is now being told he cannot use the other side of the building.

Ms. DiMascio noted that if a site that is grandfather ceases to operate all or any portion of that grandfathered use for a period of 1 year then the grandfathering use is lost.

Mr. Maruti indicated he did have an occupancy certificate for the operation that is currently going on and wanted to know if he could still do continue that use.

Ms. DiMascio stated that if there was an occupancy issued for that use to him he could continue to operate.
