

## White Oak Pool Private Rental Agreement

The White Oak Pool is available to rent for private parties and group functions. The rental time is from **8:00pm – 11:00 pm**. If the renter wishes to have the party from **7:00 pm – 10:00 pm** it can be arranged for the same cost, but the pool will not be private until **8:00pm**. The cost of the party includes use of the pool facility and locker rooms and at least 2 certified lifeguards (larger parties will have more lifeguards). Renters may bring their own food/drinks, but are asked to keep those items in the concession area. No alcoholic beverages or glass containers are permitted on the pool premises. All regular pool and park rules apply.

### The cost of renting the pool is as follows:

<b>1-50 guests:</b>	<b>\$225</b>
<b>51-100 guests:</b>	<b>\$275</b>
<b>101-150 guests:</b>	<b>\$325</b>
<b>151-200 guests:</b>	<b>\$375</b>
<b>201-250 guests:</b>	<b>\$425</b>
<b>251-300 guests:</b>	<b>\$475</b>

In order to rent the pool, the person responsible for the party must submit a *copy of their driver's license* and pay for the party at the time of booking along with a damage deposit of **\$100**.

#### *The \$100 damage fee will be reimbursed in full as long as the following conditions are met:*

- Guests and DJ's are out of the pool area by 11:00 (a prorated fee will be assessed for failure to leave the pool by the agreed upon time)
  - The garbage from the food/drinks is bagged up and not thrown around the pool grounds
  - There is no damage to the pool facility caused by a failure to follow the rules of the facility.
  - The party is not ended early due to the need to contact the police.
- If a party must be cancelled the renter must see the manager/assistant manager/head guard to sign this agreement for a full refund available through the Borough of White Oak business office.
  - In the event that the pool is closed for the day the renter will be contacted at the time of closure and will have until 6:30 to determine if they wish to cancel the party. If the party must be canceled due to a weather event an alternative day may be scheduled or a refund will be issued.
  - If the party begins and the weather prevents swimming it may be canceled up until 9:00 with a fee of 1/3 of the cost. After 9:00 there will be no reimbursements.
