## Certificate of insurance required

Liability insurance for bodily injury shall be in an amount not less than one million dollars (\$1,000,000) for each person and one million dollars (\$1,000,000) for each accident and for property damages an amount not less than one million dollars (\$1,000,000).

## Permit fees

Three square yards or less shall be \$200.00. The charge for a permit for a street opening of more than three square yards shall be the sum of the charge for a permit for three square yards or less and \$20.00 for each additional square yard or portion thereof.

## Degradation fee

The degradation fee will be paid in addition to the permit fee and will be as follows:

For streets constructed, reconstructed, or resurfaced within the following numbers of years prior to the issue date of the permit.

Less than 1 year	\$40.00 per sq. yd.
1 to 2 years	\$30.00 per sq. yd.
3 to 5 years	\$20.00 per sq. yd.
Over 5 years	\$10.00 per sq. yd.
